Initial Requirements for the DAE Designation

- Meet Education, NAIW (International) Program and Participation standards
- Complete NAIW (International)'s one hour or four hour Ethics program OR state certified Ethics program
- Hold CPIW/M Designation for minimum of three (3) years
- NAIW (International) dues must be paid for the fiscal year in which application is made

Renewal Requirements for Designation (must be renewed every five (5) years)

- Application for renewal must be made 60 days prior to five-year anniversary of conferment
- Pay \$30 renewal fee if renewed prior to your renewal date (An additional \$10 fee is charged for late renewals)
- Complete NAIW (International)'s one hour or four hour Ethics program, OR a state certified Ethics program
- NAIW membership must be continuous since CPIW/M conferment
- Meet Education, NAIW (International) Program and Participation standards during the past five years

➔ **NOTE:** Failure to re-certify will result in loss of use of the DAE designation.
